## CHAPTER 50.

## An Act respecting Christ Church Trust.

[27th February, 1912.]

WHEREAS a petition has been presented by the Very Reverend Preamble Alexander John Doull, Rector of the Parish of Christ Church, and Arthur Douglas Crease and Alexis Martin, churchwardens of the same parish, by and with the knowledge, concurrence, and consent of the Venerable Augustine Scriven, Archdeacon of Vancouver, the Honourable Paulus Emilius Irving, Alfred Cornelius Flumerfelt, and Cuyler Armstrong Holland, on Uchalf of the trustees of the Christ Church Trust, for an Act enabling the trustees for the time being of the Christ Church Trust to deal more freely with the real and personal property comprised in the said trust, or hereafter to be comprised therein, and to convey a good title to any of the lands vested in such trustees, and to apply the proceeds of any sales of trust property for any of the general purposes of the trust, and to erect buildings and to invest moneys with the powers and subject to the provisions therein set forth:

And whereas it is expedient to grant the prayer of the said petition:

Therefore, His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of British Columbia, enacts as follows ;--

1. It shall be lawful for the trustees for the time being of the Trustees may deal Christ Church Trust to sell, lease, mortgage, exchange, or otherwise for dispose of and to manage all lands and property now or hereafter vested in or held by them as such trustees, and to apply and use all moneys produced thereby and to hold any lands or property taken in exchange to or for any of the purposes of the trusts declared by the deeds of trust specified in the Schedule hereto, or any of them, or any subsequent deed or deeds of a similar character, without

respect to the source from which the said property or moneys may be derived or to the particular trusts upon which the lands or property so sold, leased, or mortgaged or otherwise disposed of or given in exchange may have been held respectively, and also to apply any of them, the said property or moneys, in erecting buildings suitable to be used for any of the purposes of the said trusts upon any lands now or hereunder to be vested in such trustees: Provided, however, that before any sale, lease, or mortgage or other disposal or exchange be contracted for, in all cases where the interests of the Lord Bishop of British Columbia shall be directly affected, his consent in writing shall first be had and obtained, and in all cases where the interests of the rector of the said parish shall be directly affected, his consent in writing shall first be had and obtained, and where the interests of the parishioners of the said parish shall be directly affected, then the consent of the rector and churchwardens (if any) of the said parish shall first be had and obtained in writing; and provided further that, notwithstanding anything in the said deeds contained, none of the powers or authorities conferred upon the said trustees by the said deeds, or any of them, or by this Act shall be exercised by less than three of the trustees for the time being acting together.

May invest in first mortgages in British Columbia. 2. The said trustees shall be at liberty to invest any trust funds upon the security of first mortgages of real estate situate in British Columbia.

Present title confirmed **3.** Save as modified by this Act, the said trustees shall be and they are hereby confirmed in all powers at present vested in them by virtue of the said trust deeds and the laws of this Province, and all lands of which they shall be registered as owners or entitled to be registered as such at the time of the passing of this Act shall be and they are hereby vested in them absolutely, subject to the trusts upon which the same shall be held respectively, and to any registered charges, and subject also to any existing rights in the streets intersecting either wholly or in part of the said lands.

Short title.

4. This Act may be cited as " Christ Church Trust Act, 1912."
