CHAPTER 74.

An Act relating to The Corporation
of the City of Victoria.

[Assented to 20th March, 1958.]

Preamble.

WHEREAS The Corporation of the City of Victoria has by its petition represented that it is necessary and expedient in the interests of the inhabitants and ratepayers of the said municipality to enact the provisions hereinafter contained, and has prayed that the same may be enacted accordingly:

And whereas it is expedient to grant the prayer of the said petition:

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of British Columbia, enacts as follows:—

Short title.

1. This Act may be cited as the "Victoria City Act, 1958."

2. Section 13 of the "Victoria City Act, 1921," being chapter 76 of the Statutes of British Columbia, 1921, as amended by the "Victoria City Act, 1922," the "Victoria City Act, 1934," and the "Victoria City Act, 1939," is hereby repealed and the following substituted therefor:—

"13. (1) Notwithstanding the provisions of the 'Municipal Act,' the nominations for Mayor and Aldermen for the City of Victoria shall be held on the first Thursday in the month of December in each year from twelve (12) o'clock noon until two (2) o'clock in the afternoon, and the polling (if any) shall be held on the Thursday following from eight (8) o'clock in the forenoon until eight (8) o'clock in the afternoon.

"(2) Notwithstanding anything contained in the 'Municipal Act,' the nominations to be held to fill a vacancy on the Municipal Council of The Corporation of the City of Victoria shall be held on a Thursday from twelve (12) o'clock noon until two (2) o'clock in the afternoon, and the polling (if any) shall be held on the Thursday following from eight (8) o'clock in the forenoon until eight (8) o'clock in the afternoon.

"(3) The first meeting of the members of the Municipal Council of The Corporation of the City of Victoria shall be held on the first Monday in January in each year, or, if the said first Monday falls upon a holiday, then on the next day thereafter that is not a holiday.

"(4) Notwithstanding anything contained in the 'Municipal Act' or the 'Public Schools Act,' the nomination and election of School Trustees from the City of Victoria shall be held annually at the same time and conducted in the same manner and by the same Returning Officer, when possible and convenient, as the nomination and election of Mayor and Aldermen pursuant to this section, and the nomination and polling to fill vacancies on the Board of School Trustees pertaining to the City of Victoria shall be held on the same respective days and times and conducted in the same manner as nominations and elections to fill vacancies on the Municipal Council."

3. Section 5 of the "Victoria City Act, 1930," being chapter 81 of the Statutes of British Columbia, 1930, is hereby repealed.
