**An Act to amend the "Greater Nanaimo Water
District Act."**

[Assented to 28th March, 1957.]

HER MAJESTY, by and with the advice and consent of the
Legislative Assembly of the Province of British Columbia, enacts
as follows:—

Short title.

1. This Act may be cited as the "Greater Nanaimo Water District
Act Amendment Act, 1957."

Re enacts
heading.

2. The "Greater Nanaimo Water District Act," being chapter 41 of
the Statutes of 1953 (Second Session), is amended by striking out the
heading and substituting the following: "An Act to establish the Greater
Nanaimo Water and Sewerage District."

Re enacts s. 1.

3. Section 1 is repealed, and the following is substituted:—

"1. This Act may be cited as the 'Greater Nanaimo Water and
Sewerage District Act.'"

Re enacts s. 2

4. Section 2 is repealed, and the following is substituted:—

"2. In this Act, unless the context otherwise requires:—

" 'Board' means the Administration Board constituted under this
Act:

" 'Chairman' means the Chairman of the Board:

" 'Community' means any municipality incorporated as a city,
town, district, village, or local district under any Act, or im-
provement district incorporated under the 'Water Act,' being
within the Greater Nanaimo Water and Sewerage District:

" 'Corporation' means the Greater Nanaimo Water and Sewerage
District incorporated under this Act:

" 'District' means the area included in the Greater Nanaimo Water and Sewerage District constituted under this Act:

" 'Sewerage collection system' includes all works, plant, structures, lands, equipment, and all other things necessary or incidental to the construction and the operation of a sewage-collection system by any one or more of the communities for the purpose of collecting sewage in any sewerage area established pursuant to this Act:

" 'Sewerage disposal system' includes all works, plant, structures, lands, equipment, and all other things necessary or incidental to the construction and the operation of a sewage-disposal system by the Corporation for the purpose of conveying the sewage from the various sewerage collection systems to the point or points of disposal, treating (if required), and disposing of the sewage:

" 'Street' includes any highway, and any public bridge, and any boulevard, square, mew, court, road, lane, alley, or passage, whether a thoroughfare or not:

" 'Watercourse' shall include any river, stream, creek, or lake, whether ordinarily carrying or containing water or not:

" 'Waterworks system' includes all works, plant, structures, lands, equipment, and all other things necessary or incidental to the completion and the operation of a waterworks system."

Amends s. 3.

5. Section 3 is amended by inserting after "Water" in the second line the words "and Sewerage".

Amends s. 5

6. Section 5 is amended by renumbering the present section as subsection (1).

Further
amends s. 5.

7. Section 5 is further amended by inserting after "systems" in the sixth line of subsection (1) the words "and a sewerage disposal system or systems".

Further
amends s. 5.

8. Section 5 is further amended by striking out the words "the operation of such waterworks" in the twelfth line of subsection (1), and substituting "such systems".

Further
amends s. 5.

9. Section 5 is further amended by adding the following as subsection (2):—

"(2) In addition to its other powers, the Corporation shall have the following powers:—

"(a) To finance, design, and construct sewerage facilities in addition to those requisite for its function for any community at the sole and exclusive cost of such community and upon the request of such community; and
