

CHAPTER 51.

An Act respecting the Corporation of the City of Vernon.

[Assented to 19th December, 1924.]

HEREAS the Corporation of the City of Vernon, pursuant to Preamble the provisions of section 235 of the "Municipal Act," chapter 52 of the Statutes of 1914, by by-law duly passed on the seventh day of April, 1924, and numbered 458, fixed the eleventh day of September, 1924, as the date upon which should be added to the current year's taxes unpaid on each parcel of land and improvements upon its assessment roll an additional fifteen per centum of the amount of such current year's taxes unpaid:

And whereas the Municipal Council of the said Corporation of the City of Vernon, by resolution dated the third day of September, 1924, altered the date fixed for such addition from the eleventh day of September, 1924, to the twenty-fourth day of November, 1924, subject to validation by the Leigslature of the Province of British Columbia:

And whereas said Municipal Council of the Corporation of the City of Vernon has prayed that its said act, when by resolution it altered the date for the purpose aforesaid, be validated:

And whereas in the public interest it is desirable to validate said act:

Therefore, His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of British Columbia, enacts as follows:-

1. The act of the Municipal Council of the Corporation of the Actions of Municipal Council validated. City of Vernon, when, by resolution passed by said Municipal Council on the third day of September, 1924, it altered the date upon which should be added to the current year's taxes unpaid on each parcel of land or improvements upon the assessment roll of the Corporation of the City of Vernon an additional fifteen per centum of the amount

of such current year's taxes unpaid from the eleventh day of September, 1924, to the twenty-fourth day of November, 1924, is hereby declared to be legal, valid, and binding on the Corporation of the City of Vernon, and the Councils thereof, and all persons whomsoever.

Failure to add taxes cured.

2. The failure of the Collector of the Corporation of the City of Vernon to add to the current year's taxes unpaid on each parcel of land or improvements upon his roll fifteen per centum of the amount thereof on the eleventh day of September, 1924, shall not be deemed to deprive or to have deprived the Corporation of the City of Vernon of the right to collect such taxes with interest thereon as provided by the "Municipal Act," and in respect thereof the Municipal Council of the Corporation of the City of Vernon and the Collector thereof shall have all the remedies provided in the said Act for the collection of taxes, and the said Collector shall add to the current year's taxes which were unpaid on the twenty-third day of November, 1924, on each parcel of land or improvements upon his roll an additional fifteen per centum of the amount thereof, and the amounts so added thereto shall, for all purposes, be deemed to have been so added as on and from the said twenty-fourth day of November, 1924.

Short title.

3. This Act may be cited as the "City of Vernon Payment of Taxes Extension Act."
