GREATER VANCOUVER WATER DISTRICT (AMENDMENT).



CHAPTER 16.

An Act to amend the "Greater Vancouver Water District Act."

[Assented to 26th March, 1952.]

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of British Columbia, enacts as follows:—

1. This Act may be cited as the "Greater Vancouver Water District Act Amendment Act, 1952."

Amends s. 12.
2. Section 12 of the "Greater Vancouver Water District Act," being chapter 22 of the Statutes of 1924, is amended by adding thereto the following sentence: "The members of the Board shall each receive fifteen dollars for each meeting attended by them."

3. Section 20 is amended by striking out subsection (4), and substituting the following:—

"(4) Each Commissioner shall hold office continuously until removed by the Board, notwithstanding anything to the contrary contained in the 'Municipal Superannuation Act' or any other Act. The Board may name one of the Commissioners as Chief Commissioner."

Further amends s. 20. 4. Section 20 is further amended by striking out subsection (5), and substituting the following:—

"(5) Each Commissioner shall receive out of the funds of the Corporation such salary as the Board may from time to time determine. Such salary shall be in addition to any salary, fee, or other emolument he may receive out of the funds of the Corporation as an officer or employee of the Corporation or for services rendered to the Corporation other than as a Commissioner."
