

CHAPTER 52.

An Act for the Relief of the Municipal Corporation of the City of Fernie.

[27th February, 1912.]

And whereas no petitions were received in answer to said notice against the construction of said works:

And whereas the said Corporation did proceed with the construction of said works and expended some five thousand dollars thereupon:

And whereas, owing to destruction of all municipal records in the fire which occurred in Fernie in 1908, the Corporation cannot prove that prior to the time of commencing said works it had passed any by-law, under and pursuant to subsection (1) of section 256 of

the "Municipal Clauses Act" and amendments thereto, for providing the means of ascertaining and determining what land or real property would be immediately benefited by the said works, and of ascertaining and determining the cost and the proportions in which the assessment was to be made on the various portions of land or real property so benefited for such cost, nor can it prove any special by-law for the same purpose has been passed by the said Corporation:

And whereas it was proposed to issue debentures of the said Corporation to defray the cost of said works when completed, but it is found that the same would not be saleable by reason of the circumstances hereinbefore recited:

And whereas a resolution has been passed by the Municipal Council of the said Corporation , sking for legislation validating the proceedings in connection with the said local improvements:

And whereas it is expedient that under the circumstances relief should be granted to the said Corporation of the City of Fernie:

Now, therefore, His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of British Columbia, enacts as follows:--

- 1. It shall be lawful for the said the Municipal Corporation of Corporation may the City of Fernie to pass a by-law nunc pro tune under subsection pro tune (1) of section 256 of the "Municipal Clauses Act" and amendments thereto hereinabove referred to, and to proceed with the said works hereinbefore recited, and to prosecute the same to completion as though such by-law had been passed by the said Corporation in accordance with the provisions of the said the "Municipal Clauses Act" and amendments thereto, and to contract temporary loans to defray the cost thereof until completion in accordance with the provisions of the said Act and amendments in that behalf; and upon completion of the said works it shall be lawful for the said Corporation to assess and levy the costs thereof against and upon the property benefited thereby in accordance with such by-law so to be passed as aforesaid, and in accordance with the provisions of the local improvements in city municipalities of the "Municipal Clauses Act" and amendments thereto, to issue debentures under the provisions of the said "Municipal Clauses Act" and amendments thereto and in accordance therewith to pay for the cost of such works, and to dispose of such debentures as by the said Act and amendments permitted and directed, and such debentures when so issued as aforesaid shall be valid and binding on the said Corporation of the City of Fernie to all intents and purposes whatsoever.
- 2. This Act may be cited as the "Fernie Local Improvement short title Relief Act, No. 2, 1912."
