- 4 (1) The regional health boards listed in column 1 of Schedule A are continued as regional health boards under section 4(1) of the Act.
 - (2) The area of British Columbia constituting the region for each regional health board is set out in Schedule B.

SCHEDULE B

FRASER HEALTH AUTHORITY

1 The Fraser Health Authority consists of the following areas:

Fraser Valley Health Region

Commencing at the intersection of the southerly boundary of the Province of British Columbia with the westerly boundary of the watershed of Similkameen River; thence northerly along the westerly boundary of the watershed of Similkameen River to the southerly boundary of theoretical Township 5, Range 23, West of the 6th meridian; thence westerly, northerly and easterly along the southerly, westerly and northerly boundaries of said theoretical Township 5 to the westerly boundary of the watershed of Similkameen River; thence northerly along the westerly boundary of the watershed of Similkameen River to the southerly boundary of the watershed of Coldwater River; thence westerly along the southerly boundary of the watershed of Coldwater River to the easterly boundary of the watershed of Anderson River; thence northerly along the easterly boundaries of the watersheds of Anderson River, Stoyoma Creek and Ainslie Creek to a point on the easterly boundary of the watershed of Ainslie Creek lying due East, a distance of 12.75 kilometres, more or less, from the northeast corner of Tsawawmuck Indian Reserve No. 1; thence due West to said northeast corner; thence westerly along the northerly boundary of Tsawawmuck Indian Reserve No. 1 to the northwest corner thereof, being a point on the natural boundary of Fraser River, on the left bank thereof; thence due West to the middle line of Fraser River; thence northerly along the middle line of Fraser River to the northerly boundary of Township 12, Range 26, west of the 6th meridian; thence westerly along the northerly boundary of Township 12, Range 26 West of the 6th meridian, to the northwest corner of Section 31 of said Township; thence due West to the northerly boundary of the watershed of Nahatlatch River; thence westerly along the northerly boundary of the watershed of Nahatlatch River to the easterly boundary of the watershed of Lillooet River, with said boundary being a portion of the summit of the Cascade Mountains as defined for administrative purposes in the Interpretation Act, Revised Statutes of British Columbia, 1996, Chapter 238; thence northerly along said summit of the Cascade Mountains to a point thereon, with said point lying due East of the northeast corner of District Lot 5536, Group 1, New Westminster District, being Baptiste Smith Indian Reserve No. 1A; thence due West to the northeast corner of District Lot 5536; thence westerly along the northerly boundary of District Lot 5536 to the northwest corner thereof; thence due West to the first point of intersection with the northerly boundary of the watershed of Billygoat Creek, with said creek being a tributary of Lillooet River; thence westerly along the northerly boundary of the watershed of Billygoat Creek to the westerly boundary of the watershed of Lillooet River; thence in a general southerly direction along the westerly boundary of the watershed of Lillooet River and continuing in a general southerly direction along the westerly boundary of the watershed of Stave River to a point thereon, with said point lying due North of the northwest corner of the District of Mission, as defined in the British Columbia Gazette dated November 13, 1969; thence due South to the most northerly northwest corner of the District of Mission; thence southerly, westerly and southerly along the westerly boundary of the District of Mission to the northerly boundary of the District of Abbotsford/Matsqui, as defined in the British Columbia Gazette dated September 8, 1994; thence westerly and southerly along the northerly and westerly boundaries of the District of Abbotsford/Matsqui to the southerly boundary of the Province of British Columbia; thence easterly along the southerly boundary of the Province of British Columbia to the westerly boundary of the watershed of Similkameen River, being the point of commencement.

Simon Fraser Health Region

Firstly, commencing at the southwest corner of the District of Mission as defined in the British Columbia Gazette dated November 13, 1969, with said corner being a point on the middle line of Fraser River; thence northerly, easterly and northerly along the westerly boundary of the District of Mission to the most northerly northwest corner thereof; thence due North to the westerly boundary of the watershed of Stave River; thence in a general northerly direction along the westerly boundary of the watershed of Stave River

to the easterly boundary of the watershed of Pitt River; thence northerly, westerly and southerly along the easterly, northerly and westerly boundaries of the watershed of Pitt River to a point on the westerly boundary of the watershed of Pitt River lying due East of the southeast corner of District Lot 2029, Group 1, New Westminster District; thence due West to the middle line of Indian River; thence southerly along the middle lines of Indian River and Indian Arm, passing to the east of Croker Island and District Lot 177 and to the west of Racoon and Boulder Islands, produced to the middle line of Burrard Inlet, with said middle line of Burrard Inlet being also the northerly boundary of the City of Burnaby as defined in the British Columbia Gazette dated April 9, 1992; thence easterly and southerly along the northerly and easterly boundaries of the City of Burnaby to the northwesterly boundary of the City of New Westminster as defined in the British Columbia Gazette dated January 8, 1970; thence southwesterly and southerly along the northwesterly and westerly boundaries of the City of New Westminster to the middle line of the South Arm of Fraser River, located north of Annacis Island, and with said middle line being also the northerly boundary of the District of Delta as defined in the British Columbia Gazette dated January 8, 1970; thence easterly along the middle line of Fraser River, passing to the north of Barnston Island to the southwest corner of the District of Mission, being a point thereon and being also the point of commencement. Secondly, comprised of the City of Burnaby as defined in the British Columbia Gazette dated April 9, 1992.

South Fraser Health Region

Commencing at the southwest corner of the District of Abbotsford/Matsqui, with said corner being defined in the British Columbia Gazette, dated September 8, 1994, and being also a point on the southerly boundary of the Province of British Columbia; thence northerly along the westerly boundary of the District of Abbotsford/Matsqui to the middle line of Fraser River; thence westerly along the middle line of Fraser River, passing to the north of Barnston Island, to the northerly boundary of the District of Delta as defined in the British Columbia Gazette dated January 8, 1970; thence in a general westerly and southerly direction along the northerly and westerly boundaries of the District of Delta to the southwest corner thereof, being a point on the southerly boundary of the Province of British Columbia; thence easterly along the southerly boundary of the Province of British Columbia to the southwest corner of the District of Abbotsford/Matsqui, being the point of commencement.

INTERIOR HEALTH AUTHORITY

2 The Interior Health Authority consists of the following areas:

and southerly boundaries of the watershed of Kitlope River to the easterly boundary of the watershed of Nascall River; thence northerly, westerly and southerly along the easterly, northerly and westerly boundaries of the watershed of Nascall River to a point on said westerly boundary lying due East of the most northerly point on the natural boundary of Cascade Inlet; thence due South to the middle line of Cascade Inlet; thence southeasterly along the middle line of Cascade Inlet produced to the middle line of Dean Channel; thence southwesterly along the middle line of Dean Channel and continuing southerly along the middle line of Fisher Channel and Fitz Hugh Sound to the southwesterly prolongation of the middle line of Burke Channel; thence northeasterly to and along the middle line of Burke Channel to a point thereon, with said point being due North of the intersection between the natural boundaries of Burke Channel, on the southerly shore thereof, and Nootum River, on the right bank thereof; thence due South to said intersection; thence due East to the easterly boundary of the watershed of Nootum River; thence southerly along the easterly boundary of the watershed of Nootum River to the northerly boundary of the watershed of Koeye River; thence easterly, southerly and westerly along the northerly, easterly and southerly boundaries of the watershed of Koeye River to a point on said southerly boundary lying due North of the northeast corner of District Lot 1225, Range 2, Coast District; thence due South to said northeast corner; thence southerly along the easterly boundary of District Lot 1225 produced to the middle line of Hardy Inlet; thence easterly along said middle line of Hardy Inlet produced to the middle line of Moses Inlet; thence southerly along the middle line of Moses Inlet produced to the middle line of Rivers Inlet; thence in a general easterly direction along the middle lines of Rivers Inlet, Wannock River and Owikeno Lake to a point on the middle line of Owikeno Lake lying due North of the intersection between the natural boundaries of Owikeno Lake, on the southerly shore thereof, and Doos Creek, on the right bank thereof; thence due South to said intersection; thence southeasterly in a straight line, on a bearing of 150°, to the intersection with the westerly boundary of the watershed of Marble Creek; thence in a general southerly direction along the westerly boundaries of the watersheds of Marble and Kulee Creeks to the southerly boundary of the watershed of Machmell River; thence easterly along the southerly boundary of the watershed of Machmell River to the westerly boundary of the watershed of Klinaklini River; thence northerly and easterly along the westerly and northerly boundaries of the watershed of Klinaklini River to the easterly boundary of the watershed of Jobin Creek; thence southerly along the easterly boundary of the watershed of Jobin Creek to the ridge separating those creeks that flow easterly into Klinaklini River, and lying to the north of Klinaklini Lake, from those flowing southerly into Klinaklini River, and lying to the south of Klinaklini Lake; thence southeasterly along said ridge produced to the most westerly point on the natural boundary of Klinaklini Lake, being the outlet of Klinaklini Lake; thence southeasterly in a straight line, on a bearing of 150°, to the southerly boundary of the watershed of Klinaklini Lake; thence easterly along the southerly boundary of the watershed of Klinaklini Lake to the westerly boundary of the watershed of Colwell Creek; thence northeasterly in a straight line to the point of intersection between the northerly boundary of the watershed of Clearwater Lake with the 125th meridian of west longitude; thence northerly along the surveyed 125th meridian of west longitude to its intersection with the 53rd parallel of north latitude, being the point of commencement.

Commencing at the most westerly point of Cape Caution, being a point on the natural boundary of Queen Charlotte Sound on the northeasterly shore thereof; thence southeasterly along said natural boundary of Queen Charlotte Sound to the natural boundary of Silvester Bay, on the northerly shore thereof; thence easterly along said natural boundary of Silvester Bay to the most westerly southwest corner of District Lot 239, Range 2, Coast District; thence easterly and northerly along the southerly and easterly boundaries of District Lot 239 to the southwest corner of District Lot 241; thence northerly and easterly along the westerly and northerly boundaries of District Lot 241 to the southwest corner of District Lot 748; thence easterly along the southerly boundary of District Lot 748 to the southeast corner thereof; thence due East to the southerly boundary of the watershed of Takush River; thence easterly along the southerly boundaries of the watersheds of Takush River, Wyclees Lagoon and Long Lake to the southeasterly boundary of the watershed of Smokehouse Creek; thence northeasterly and northerly along the southeasterly and easterly boundaries of the watershed of Smokehouse Creek to the southerly boundary of the watershed of Machmell River; thence easterly along the southerly boundary of the watershed of Machmell River to the westerly boundary of the watershed of Klinaklini River; thence northerly and easterly along the westerly and northerly boundaries of the watershed of Klinaklini River to the easterly boundary of the watershed of Jobin Creek; thence southerly along the easterly boundary of the watershed of Jobin Creek to the ridge separating those creeks that flow easterly into Klinaklini River, and lying to the north of Klinaklini Lake, from those flowing southerly into Klinaklini River, and lying to the south of Klinaklini Lake; thence southeasterly along said ridge produced to the most westerly point on the natural boundary of Klinaklini Lake, being the outlet of Klinaklini Lake; thence southeasterly in a straight line, on a bearing of 150°, to the southerly boundary of the watershed of Klinaklini Lake; thence easterly along the southerly boundary of the watershed of Klinaklini Lake to the westerly boundary of the watershed of Colwell Creek; thence southerly along the westerly boundaries of the watersheds of Colwell and Mosley Creeks to the westerly boundary of the watershed of Homathko River; thence southerly along the westerly boundary of the watershed of Homathko River to the northerly boundary of the watershed of Stafford River; thence westerly along the northerly boundary of the watershed of Stafford River to the easterly boundary of the watershed of those creeks flowing westerly into Knight Inlet; thence southerly and westerly along the easterly and southerly boundaries of the watershed of those creeks flowing into Knight Inlet to a point on said southerly boundary, with said point being due East of the southeast corner of Pawala Indian Reserve Number 5, being District Lot 1526, Range 1, Coast District; thence due West to the southeast corner of Pawala Indian Reserve Number 5; thence westerly along the southerly boundary of Pawala Indian Reserve

Number 5 produced to the middle line of Call Inlet; thence southwesterly along the middle line of Call Inlet and Havannah Channel, passing to the east of Hull Island and to the south of Mistake and Bockett Islands, produced to the middle line of Johnstone Strait; thence easterly along the middle line of Johnstone Strait to a point thereon, with said point being due North of the northeast corner of District Lot 222, Rupert District; thence due South to the northeast corner of District Lot 222; thence southerly along the easterly boundary of District Lot 222 to the easterly boundary of the watershed of Adam River; thence southerly along the easterly boundary of the watershed of Adam River to the easterly boundary of the watershed of Nimpkish River; thence southerly, southwesterly, westerly and northwesterly along the easterly, southeasterly, southerly and southwesterly boundaries of the watershed of Nimpkish River to the easterly boundary of Zeballos Forest Service Road as shown on File 942-8640 on deposit with the Ministry of Forests; thence southerly along the easterly boundary of Zeballos Forest Service Road to the northerly boundary of the Village of Zeballos as defined in the British Columbia Gazette dated July 10, 1952; thence in general easterly, southerly, northwesterly, northerly and easterly directions around the perimeter boundaries of the Village of Zeballos to the intersection of the northerly boundary of the Village of Zeballos with the westerly boundary of said Zeballos Forest Service Road; thence northerly along the westerly boundary of Zeballos Forest Service Road to the southwesterly boundary of the watershed of Nimpkish River; thence northwesterly along the southwesterly boundary of the watershed of Nimpkish River to a point thereon, with said point being due East of the southeast corner of District Lot 1259; thence due West to the southeast corner of District Lot 1259; thence westerly and northerly along the southerly and westerly boundaries of District Lot 1259 to the northwest corner thereof, being a point on the natural boundary of Atluck Lake, on the southwesterly shore thereof; thence in a general northerly direction along the natural boundary of Atluck Lake, on the westerly shore thereof, to the southwest corner of District Lot 1260; thence northerly along the westerly boundary of District Lot 1260 to the northwest corner thereof; thence due North to the westerly boundary of the watershed of Atluck Lake, being also the westerly boundary of the watershed of Nimpkish Lake; thence northerly along the westerly boundary of the watershed of Nimpkish Lake to the southerly boundary of the watershed of Raging River; thence westerly along the southerly boundaries of the watersheds of Raging River, Benson Lake, Victoria Lake and Neroutsos Inlet to the southeasterly boundary of the watershed of Klaskish River; thence southwesterly along the southeasterly boundaries of the watersheds of Klaskish River, Klaskish Inlet and Brooks Bay to the most westerly point of Cape Cook on Brooks Peninsula; thence due West to the westerly boundary of the Province of British Columbia; thence northwesterly along the westerly boundary of the Province of British Columbia to the 51st parallel of north latitude; thence easterly along the 51st parallel of north latitude to the 128th meridian of west longitude; thence northeasterly in a straight line to the most westerly point of Cape Caution, being a point on the natural boundary of Queen Charlotte Sound, on the northeasterly shore thereof, and also being the point of commencement.
