ARROWSTONE RESERVE

All those parcels or tracts of Crown land, together with all that foreshore or land covered by water, situated in Kamloops Division of Yale District and contained within the following described boundaries.

Commencing at the southeast corner of District Lot 567;

thence northerly along the easterly boundary of District Lot 567 a distance of 150 metres;

thence due east to the westerly boundary of Battle Creek Forest Service Road as shown on File 942-8452-01 with the Ministry of Forests in Victoria;

thence in a general southerly direction along the westerly boundary of Battle Creek Forest Service Road to a point thereon, said point being the intersection with the northeasterly production of the northwesterly boundary of District Lot 6326, Kamloops Division of Yale District being Ranchlands 6, 7, 8 and 9 Mineral Claims;

thence southwesterly to and along the northwesterly boundary of District Lot 6326 to the most westerly corner thereof;

thence southeasterly along the southwesterly boundary of District Lot 6326 produced to the northwesterly boundary of the BC Hydro right-of-way shown on Plan C-8299 on deposit in the Kamloops Land Title Office;

thence southwesterly along the northwesterly boundary of Plan C-8299 to the northerly boundary of Section 16, Township 21, Range 23, west of the 6th meridian, Kamloops Division of Yale District;

thence westerly and southerly along the northerly and westerly boundaries of said Section 16 to the northerly boundary of Trans-Canada Highway Number 1, as shown on Plans H-684/H-686 on deposit in the Kamloops Land Title Office;

thence in a general westerly direction along the northerly boundary of Plan H-686 to the northerly boundary of District Lot 8, Group 2, Yale-Lytton Division of Yale District;

thence westerly along the northerly boundary of District Lot 8, Group 2, Yale-Lytton Division of Yale District to the easterly boundary of District Lot 437, Kamloops Division of Yale District;

thence northerly along the easterly boundary of District Lot 437 to the northeast corner thereof;

thence due north to the natural boundary of an unnamed creek, on the left bank thereof, with said unnamed creek flowing southerly through District Lot 437;

thence northerly along said natural boundary of the unnamed creek flowing southerly through District Lot 431 to the intersection with the 800 metre contour;

thence northwesterly in a straight line on a bearing of 290°, a distance of 1540 metres, more or less, to the natural boundary of an unnamed creek, on the left bank thereof;

thence southwesterly in a straight line on a bearing of 187°, to the northerly boundary of the fractional north ½ of Section 14, Township 21, Range 24, west of the 6th meridian;

thence westerly along said northerly boundary to the northeast corner of the fractional north ½ of the northwest ¼ of said Section 14;

thence southerly along the easterly boundary of said fractional north ½ of the northwest ¼ to the northeasterly boundary of District Lot 7, Group 2, Yale-Lytton Division of Yale District;

thence northwesterly along the northeasterly boundary of District Lot 7, Group 2, Yale-Lytton Division of Yale District to the easterly boundary of District Lot 435, Kamloops Division of Yale District;

thence northerly, westerly and southerly along the easterly, northerly and westerly boundaries of District Lot 435 to the northerly boundary of Trans-Canada Highway Number 1, as shown on Plans H-684/H-686 on deposit in the Kamloops Land Title office;

thence northwesterly along the northerly boundary of Plan H-684 to the southeasterly boundary of District Lot 5, Group 2, Yale-Lytton Division of Yale District;

thence northeasterly and northwesterly along the southeasterly and northeasterly boundaries of said District Lot 5 to the most easterly corner of District Lot 3;

thence northwesterly along the northeasterly boundary of District Lot 3 to the southeasterly boundary of Back Valley Road, a Section 4 Highway Act road identified on the Highway Road Register as road #2026;

thence northeasterly along the southeasterly boundary of Back Valley Road to the southwesterly boundary of District Lot 6325, Kamloops Division of Yale District, being Ranchlands 1, 2, 11 and 12 Mineral Claims;

thence southeasterly, northeasterly and northwesterly along the southwesterly, southeasterly and northeasterly boundaries of District Lot 6325 to the most northerly corner of District lot 6325;

thence southwesterly along the northwesterly boundary of said lot to a point, said point being due east of the northeast corner of the southeast $\frac{1}{4}$ of Section 32, Township 21, Range 24, west of the 6th meridian;

thence due west to said northeast corner of the southeast $\frac{1}{4}$ of Section 32;

thence westerly along the northerly boundary of the southeast $\frac{1}{4}$ of Section 32 to the southeast corner of Legal Subdivision 10 of Section 32;

thence northerly along the easterly boundary of said legal Subdivision 10 to the southeast corner of the south $\frac{1}{2}$ of Legal Subdivision 15 of Section 32;

thence northerly and westerly along the easterly and northerly boundaries of the south $\frac{1}{2}$ of Legal Subdivision 15 of Section 32 to the northeast corner of the south $\frac{1}{2}$ of the north $\frac{1}{2}$ of the northwest $\frac{1}{4}$ of Section 32;

thence westerly along the northerly boundary of the South $\frac{1}{2}$ of the north $\frac{1}{2}$ of the northwest $\frac{1}{4}$ of Section 32 and continuing westerly along the south $\frac{1}{2}$ of the north $\frac{1}{2}$ of the north $\frac{1}{2}$ of Section 31, Township 21, Range 24, west of the 6th meridian to the easterly boundary of the most easterly unnamed road shown on B.C. Lands Ministerial Reference Map R921.084, dated October 17, 1994;

thence in a general northerly direction along the easterly boundary of said road a distance of approximately 500 metres to a point thereon, said point being the junction with an unnamed road, on the southerly boundary thereof;

thence due north to the northerly boundary of said unnamed road;

thence in a general northwesterly then northerly direction along the easterly boundary of said road, to the Indian Hills Main Forest Service Road as shown on File 942-5482-01 with the Ministry of Forests in Victoria;

thence in general northerly and easterly directions along the southerly, easterly and southerly boundary of Indian Hills Main Forest Service Road to a point thereon, said point being due south a distance of 80 metres and due east a distance of 8.15 kilometres, more or less, of the northeast corner of Section 3, Township 23, Range 25, west of the 6th meridian;

thence northeasterly in a straight line on a bearing of 73°, a distance of 350 metres;

thence southeasterly in a straight line on a bearing of 127°, a distance of 1.0 kilometre, more or less, to the southerly boundary of said Indian Hills Main Forest Service Road;

thence in a general easterly direction along the southerly boundary of Indian Hills Main Forest Service Road to the westerly boundary of Arrowstone Creek Forest Service Road as shown on File 942-8735-01 with the Ministry of Forests in Victoria;

thence in a general southerly direction along the westerly boundary of Arrowstone Creek Forest Service Road to a point thereon, said point being due north of the northeast corner of District Lot 5837, a distance of 7.8 kilometres, more or less;

thence southwesterly in a straight line on a bearing of 182°, a distance of 5.10 kilometres, more or less, to the 1300 metre contour;

thence southeasterly in a straight line on a bearing of 162°, a distance of 2.20 kilometres, more or less, to the 1200 metre contour;

thence southeasterly in a straight line on a bearing of 138°, a distance of 1.60 kilometres, more or less, to the southerly boundary of Back Valley Road;

thence easterly along the southerly boundary of Back Valley Road to the natural boundary of an unnamed creek, on the right bank thereof, with said creek flowing southerly into Tsotin (Dairy) Lake;

thence southerly along said natural boundary of the unnamed creek to the northerly boundary of District Lot 567;

thence westerly, southerly and easterly along the northerly, westerly and southerly boundaries of District Lot 567 to the southeast corner thereof, being the point of commencement;
