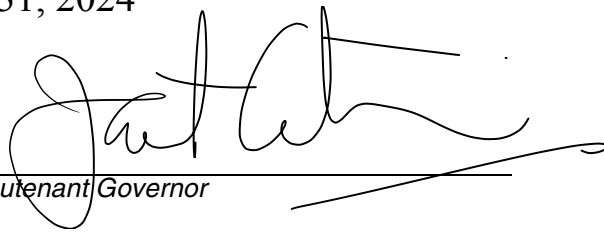

SAFE ACCESS TO SCHOOLS REGULATION

Definition

- 1** In this regulation, “**Act**” means the *Safe Access to Schools Act*.

Access zones

- 2** Access zones are established for the following schools:
- (a) schools operated by a board of education, other than the Qwam Qwum Stuwixwulh Community School in the City of Nanaimo;
 - (b) schools operated by a francophone education authority;
 - (c) schools operated by an independent school authority, other than the schools set out in column 2 of the Schedule to this regulation.

Designated policing unit

- 3** For the purposes of the definition of “police officer” in section 1 of the Act, the designated policing unit known as the Stl’atl’imx Tribal Police is prescribed.
