**SUBJECT: Additional Weight Tolerance for Auxiliary Power Units (APUs)**

**PURPOSE OF CIRCULAR**

To advise industry, staff and the general public about the additional weight tolerance allowed for Auxiliary Power Units (APUs) installed on truck tractors and straight trucks. The weight tolerance is only permitted on the steering axle and drive axle group to a combined maximum weight allowance of 225kg (500lb).

**BACKGROUND**

An APU provides power for heating, AC and ancillary devices when a truck tractor or straight truck is parked, saving fuel and reducing greenhouse gases by eliminating the need to idle the vehicle's engine. Currently, 25 US states provide weight allowances for APUs.

The BC Trucking Association (BCTA) and the Trucking Sector Climate Action Working Group (TSWG) have recommended Commercial Vehicle Safety & Enforcement (CVSE) allow a weight exemption for BC truck tractors and straight trucks equipped with these APUs.

**IMPLEMENTATION**

CVSE has agreed to the recommendation by BCTA and TSWG and has developed the following procedure companies/drivers are to follow in order to get the weight exemption:



- Driver must report to the closest inspection station for a one time only verification the truck tractor or straight truck is equipped with an APU.
- Once a CVSE Inspector confirms an APU has been installed, a decal (as shown on the left) will be affixed to the passenger side window to indicate the unit is equipped with an APU.
